Medical Action Industries develops, manufactures and distributes disposable surgical products. Additionally, the company provides a range of products for the collection and deposition of hazardous biomedical waste. We continue to recommend Medical Action Industries as a fast growing medical products company. The stock of MEDIC has risen modestly (up \$1.03 per share) since our recommendation on August 5, 2003, while the overall market has also risen modestly.

We continue to recommend Medical Action Industries for the following reasons:

- Medical Action Industries is a supplier of surgical products, which will benefit from the aging of the “baby boomers” who are the greatest users of surgical procedures. The recent concerns over drug costs will not affect this company.
- **Medical Action Industries** is the leading company in disposable medical products; an industry that is fragmented and consolidating. The company has been and continues to be an aggressive acquirer of small to medium sized medical product companies. As the industry continues to consolidate, the profit margins (which are good) will improve significantly.
- **Medical Action Industries** is a very well managed company, which has achieved superior results. We estimate that 20% plus annual growth is easily achievable over the next several years.
- The company has had record revenues over each of the last eight years and record net income over each of the last six years.

We believe Medical Action Industries at \$14 per share is attractively priced and we maintain our target price of \$24 per share.
